student in each subject to five lectures.

Promotion Criteria under Semester System

- I. A student will be eligible for promotion from Semester-I to II, Semester-III to IV and Semester-V to VI, if he/she has:
- a) Secured pass marks in Internal Assessment and Tutorial of all the subjects/papers of the Semester-I/III/V as the case may be.
- b) Has appeared in the Semester-End Examination of Semester-I/III/V as the case may be.
- A student will be eligible for promotion from Semester-II to III and Semester-IV to V provided he/she has passed at least 75% Of the subjects/papers Of the theory/practical (separately) of Semesters-1/111 as the case may be and passed in Internal Assessment of all subjects/papers of Semester-II/IV as the case may be.

A student will be eligible for promotion from Semester-V to VI provided he/she has passed in all subjects/papers of Semester-I and Semester-III.

A student who has to reappear in a subject/paper prescribed for Semester-I to IV shall appear in the subsequent Semester examination to be held as per the dates prescribes by the University.

Provided that a student who does not fulfill the promotion of criteria 2, 3 and 4 above shall be declared fail in the Semester concerned. However, he/she shall have the option to retain the marks in the paper in which he/she has secured pass marks as per statue 37.

 A student who has to reappear in a subject(s)/paper(s) prescribed for Semester V and VI shall appear in the supplementary examination.



No outsider is allowed to enter the college premises without a valid reason.

All students have to be in specified uniform.

Any student if found absent from college without permission for more ten consecutive days shall be terminated from the college rolls.

To monitor the regularity and progress of their wards, parents/guardians are expected to be in touch with the college authorities. Feedback based on the monitoring of attendance helps students maintain the minimum required attendance.

Use of Mobile is strictly banned.

Unlawful assembly of students in the college is prohibited.

Writing of gratification on the walls or sticking posters is a cognizable offence.

Ragging in any form, on or off the college campus, is a cognizable offence punishable under the Anti Ragging law. This may also include expulsion from the college and rustication.

Writing of graffiti or sticking of posters and spitting in any way is a cognizable offence punishable under Disaster Management Act and will be fined Rs. 500.

Use of unfair means in the examinations is violation of University rules and is liable for issuance of bad character certificate.

COLLEGE UNIFORM

Every student shall regularly bring 'Identity Card' issued by the College. College authorities can check the card anytime, anywhere in the premises.

Books issued if found damaged or lost in any way shall have to be replaced by the borrower failing which, double the cost of the book shall be charged.

Books are issued for a period of 14 days only after that Re 1/day will be charged.

Students can borrow two books from the library at a time as per the given schedule.

- 3. Production of income certificate/other certificates as and when required
- 4. Attested copy of Domicile certificate

Applications for the grant of the scholarship are dully scrutinized by the committee of teachers who recommends the deserving cases to the principal.

Students applying for the scholarship are required to submit the following particulars

- 1. Father/guardian's occupation certificate
- 2. Income Certificate Of the father[Guardian

- 3. Attested copy of Domicile certificate
- 4. Category certificate issued by the competent authority
- 5. Testimonials if any.

•The income certificate of the father/guardian should be issued and certified by the revenue officer not less than the rank Of the Tehsildar. Scholarship Of the students who do not show satisfactory academic progress will be stopped as the case may be.

Career Counseling Cell

The college has career counseling cell under the guidelines Of senior faculty Of the college. The career counseling cell provides information regarding the subject combination and counsels the students.

Women Counselling Cell/Protection Cell

The college has a women counselling/ protection cell to deal with the problems exclusively faced by the female students. Members of the cell shall meet at least once in a fortnight to listen the problems of female students and to find workable solution to their problems.

Co-curricular Activities

• Beside teaching programmes, the college provides maximum possible opportunities to the students for the expression of their talent through various programmes like debates, discussions, quizzes, and symposiums. Literary activities like essay writing, poetry recitation, painting competition and varieties of programmes are held at various levels.

•<u>National Service Scheme (NSS):</u>

The college has one unit of NSS consisting of 100 volunteers. The unit functions under a programme officer. The students have to apply on a prescribed form to seek admission in the unit. Students enrolled as NSS volunteers are required to put at least 120 Hrs of social work and attend one camp of 10 days duration to become eligible to receive a certificate. The special camp at university level and a national integration camp are also organized every year during summer/winter vacations.
